The Promoter of the Draw is the SAFA Development Agency Trust ("The Promoter"). The following printed terms and conditions are the complete rules in respect of the SAFA Development Agency Football Experience Draw ("The Draw"). It is deemed that by purchasing this ticket that you abide by these terms and conditions and that you agree to them as they stand without amendment. The cost of a ticket to enter the Draw is R500.00 (Five Hundred Rand) ("The Ticket Price"). An electronic ticket confirmation will be sent to all entrants upon receipt of the Ticket Price.

The financial regulation of The Draw will be provided by Certified Master Auditors Incorporated (CMA Inc). The Prize will be 2 (two) VIP tickets to a Tier 1 English Football Match (excluding Cup Finals) plus 2 (two) business class round trip airline tickets from Johannesburg to the UK including any usual or customary airport taxes, as described by IATA plus accommodation in a Four Star minimum Hotel.

The Prize includes ground transportation in London, internal flights (if necessary) to and from the selected city.

The total value of The Prize will be approximately R300 000.00 (Three Hundred Thousand Rand). No telephone calls, laundry costs, gifts and any other items of a personal nature are included in the prize.

The winner and his/her companion must be in possession of or be able to obtain a valid passport suitable for international travel. In addition the winner and his/her companion must be able to obtain the relevant visas for the trip. The winner and his/her companion will be responsible for the costs of obtaining visas and passports and for any personal or other insurance requirements.

In order for the Promoter to fix air flight bookings, the Winner must provide the names of the two persons that will be taking up the prize by no later **than 25 November.**

The date for departure to Europe will be determined in consultation with the winner but it must be remembered that the English Football Season takes place between August 2017 and May 2018. The winner will be able to extend the duration of the trip but all costs associated with these changes will be for the winner's account. Airline flights are subject to

availability and can only be booked through the Promoter or the Promoter's Agent. The airline tickets have no cash value. The accommodation is not transferable and has no cash value. All airline flights will be on a confirmed basis. Once a booking has been confirmed by the prize winner, no changes are permitted. If a booking is cancelled, no alternative airline tickets will be issued and the airline tickets will be deemed to have been used by the prize winner and the winner will have no further claim against the Promoter or the Promoter's agents. The prize winner shall abide by and be subject to the airline's published terms and conditions of carriage.

The prize winner will be chosen by means of a lucky draw or another manner.

A total number of 3000 (Three Thousand) tickets only will be offered for sale. If insufficient tickets are sold to cover the cost of the prize and by the expenditure the prize will be a cash amount as determined by Certified Master Auditors Incorporated (CMA Inc), whose decision will be final and binding on all entrants. Members of the SAFA Development Agency and their spouses are not eligible to enter The Draw but may accept a position by appointment of the prize winner to accompany the prize winner as a guest.
